Why make a planned gift?

A bequest in your will is an effective way to leave a lasting legacy that will continue to support future generations.


By making a donation to our programs, you allow us to apply your donation to the Mission's priority needs at the time we receive it.

- It provides immediate tax benefits to you or your estate (following the terms and conditions of your donation); and
- it finances a substantial bequest with only a minimal investment from your personal assets.

Trusts

Charitable remainder trusts provide revenue for life, along with immediate, substantial tax savings – all the while supporting Welcome Hall Mission programs.
